5th UPDATED LIST OF BANNED SUBSTANCES AND WHOLESALERS WHO ARE SELLING ILLEGAL PRODUCTS

To all Louisiana Permit Holders:

The Louisiana Office of Alcohol and Tobacco Control (ATC) has identified a number of products being offered for sale by our permittees which have tested positive for the legend drug Sildenafil and controlled dangerous substances, to include, but not limited to, testing positive for “THC” or tetrahydrocannabinol, synthetic marijuana, and other synthetic drugs that can cause hallucinations. Additionally, the Agency has identified three wholesalers who have sold products that have tested positive for either controlled dangerous substances or Sildenafil, namely:

- Smoke Nation LLC, 3600 S. Park Road, Bay 3, Pembroke Park, FL 3309
- Eshaan Wholesale LLC, 9939 Airline Hwy., Baton Rouge, LA 70816
- Twisted Lab LLC, 6574 North State Road 7, Unit 307, Coconut Creek, FL 33073

In response to continued complaints regarding the sale of products containing controlled dangerous substances, the ATC began an investigation which has uncovered several products labelled as “CBD” or hemp products being sold or offered for sale by retailers across the state that have been tested and determined to contain a component classified as a scheduled controlled dangerous substance as set forth in Schedules I, II, III, IV, and V under La. R.S. 40:964. Specifically, testing has found some “CBD” and hemp products that contain THC, synthetic marijuana, and/or other scheduled substances. Additionally, ATC has discovered multiple enhancement pills offered for sale across the state that contain the legend drug Sildenafil, which require a physician’s prescription. In an effort to protect the public health, safety and welfare, the ATC is again providing permit holders, including retailers and industry members, a listing of products being offered for sale which thus far have tested positive for a controlled dangerous substance. Products with the following labels have tested positive for Controlled Dangerous Substances and are not to be sold by retailers (this list includes all of the products discovered by ATC thus far and is by no means a comprehensive list - ATC will add products that test positive for CDS periodically as needed):

The Louisiana Office of Alcohol and Tobacco Control has become aware of the following products being sold by our permitted wholesalers and retailers that have been tested and determined to contain the prescription drug Sildenafil:

- Rhino 7
- Rhino 11
- Rhino 69
- Black Panther
- Street Overlord,
- Willy Go Wild.

Additionally, several gold capsules and black capsules for sale in unlabeled clear containers have tested positive for the prescription drug Sildenafil.

All permit holders are responsible to ensure that all products being sold or offered for sale are legal and do not contain any substance classified as a controlled dangerous substance, legend drug, or any other restricted item. The ATC will be taking an aggressive stance against the sale and distribution of any illegal or prohibited items. The agency will continue to vigilantly test and investigate any products suspected to contain an illegal component and intends to hold permit holders responsible for the illegal sale to the full extent provided by law.
